## **JOSEPH'S SERVICE MAP! (LEGEND)**

**Box #1:**

San Francisco Unified School District Transition Program after high school (for students age 18 - 22). Joseph has one-to-one paraprofessional support. This is a federally and state funded program.

**Box #2:**

In Home Support Services are personal services (feeding, bathing, food preparation, dressing, etc.) paid for by the federal Department of Health and Human Services (HHS) through the City of San Francisco, for persons with disabilities over 18 years old, receiving Supplemental Security Income (SSI). Hours are allocated after an assessment - 283 hours/month is the current maximum allocated in San Francisco equaling approximately \$2500/mo. Joseph is the employer of this individual.

**Box #3:**

Supported Employment (individual in a community employment setting with support) is an adult employment program provided by The Arc S.F. Joseph could enter after leaving the school district in June 2002. This program's funding is split between (or matched by) the Department of Rehabilitation (state) and the Home and Community Based Waiver (federal) programs. Joseph will require one-to-one support.

**Box #4:**

Independent Living Services are services designed to teach Joseph to become more independent in his home. The Arc S.F. as a vendor of Golden Gate Regional Center provides these services. The funding for ILS is split between (or matched by) GGRC (state) and the Home and Community Based Waiver (federal) programs. The number of hours allocated is determined by Joseph's needs and goals delineated in his Individualized Program Plan (IPP).

**Box #5:**

Supplemental Security Income (SSI) disability benefits are paid to people who have a disability, earn little or no income and own assets not to exceed \$2000. SSI is a program financed through general (federal) tax revenues - not through the Social Security trust funds. Joseph receives \$750.00/month. People eligible for SSI are automatically eligible for Medi-Cal.

**Box #6:**

The Department of Housing and Urban Development (HUD) has awarded a Section 8 Voucher to the apartment building that Joseph lives in. The local Housing Authority administers this federal rental subsidy program. HUD determines the fair market rent for his part of the apartment (\$600/mo.). Joseph can only be required to pay up to 30% of his income in rent (\$220.mo.). HUD pays the difference directly to the landlord.

**Box #7:**

Supported Living Services are for individuals with severe disabilities to help them live in their local community. The Arc S.F. as a vendor of Golden Gate Regional Center provides these services. The funding for SLS is split between (or matched by) GGRC (state) and the Home and Community Based Waiver (federal) programs. The number of hours allocated is determined by Joseph's needs and goals delineated in his Individualized Program Plan (IPP).

**Box #8:**

Integrated Work Program is a completely individualized program combining paid work and community activities. This program usually maintains a 1:3 ratio of client to staff but Joseph's level of need will require a 1:1 ratio. The Arc S.F. as a vendor of Golden Gate Regional Center provides this program, developing the job, and providing the coaching and supervision for Joseph. Funding for IWP is split between (or matched by) GGRC (state) and the Home and Community Based Waiver (federal) programs.
